Seek companies with a favorable combination of low valuation, high momentum, high quality and dividend yield investment factors.

Reconstitute and Rebalance

Reapply the investment process twice a year in March and September to ensure the portfolio stays true to the rules-based index methodology.

Nominal Companies represents the total number of companies included in the portfolio, regardless of allocation. Effective Companies measures portfolio concentration, in which a higher number would indicate a more diversified portfolio. Debt-to-equity ratio measures a company's financial leverage calculated by dividing its total liabilities by stockholders' equity. Return on Equity is the average amount of net income after taxes that a firm is able to earn as a percent of stockholders equity. Index Dividend Yield is the weighted average dividend yield of the securities in the underlying portfolio index (including cash). The number is not intended to demonstrate income earned or distributions made by the Fund and is not necessarily indicative of the dividend yield of the Fund.
