EPS Growth Rate is the projected growth rate in earnings per share for the next five years. Price/Book is the ratio of a stock's price to its book value per share. Price/Earnings is the ratio of a stock's price to its earnings per share. Return on Equity is the average amount of net income returned as a percentage of shareholder's equity over the past five years. R Squared represents the percentage of the portfolio's movement that can be explained by the market. Turnover is a measure of the Fund's trading activity which represents the portion of the Fund's holdings that has changed over a twelve-month period through the Fund's fiscal year end. Turnover shown excludes To-Be-Announced roll transactions, if any.
